#### SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. - Franklinville CSD will continue to work with the New York State Department of Health, Cattaraugus County Department of Health and other agencies as needed to ensure the health and safety of our students. ARP-ESSER funds may be used to purchase sanitizing supplies, personal protective equipment, additional classroom furniture or employ additional staff to meet NYS and CDC guidance for safety protocols, such as social distancing.

  - Franklinville CSD currently uses a Multi-Tiered Framework for Assessment & Instruction. STAR asssessment tools along with F&P Benchmark testing are used to track student progress. The district will continue to analyze the results of student assessments and provide interventions as outlined in the District's RTI & AIS plan.
- 5. Franklinville CSD will maintain small class sizes to allow for greater individualized attention in the classroom. In addition, the district will analyze student achievement data and enhance various instructional programs to lower any achievement gaps seen from the loss of instructional time during the pandemic. Franklinville CSD has designed a comprehensive summer that provides educational and enrichment opportunities for students in Grades K-8. The district will continue to enhance the summer programming going forward. The district will also continue to provide after school learning opportunities for students during the school year.

6. In the space provided below, please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) - the allowable uses of funds - of the ARP Act.

Purchase of Educational Technology - Franklinville CSD is fortunate to provide 1:1 technology devices for students in grades K-12. As technologies have changed over time, the district has moved to utilizing laptops instead of Ipads. The use of laptops has allowed the district to provide better access through times of remote learning instruction. In order to maintain this opportunity moving forward, the district will be upgrading its technology devices over the next several years. The district will also be looking at providing other technology devices, hardware and software that will enhance the students learning opportunities. With the greater use of technology comes the risks of cyber threats. The district will also be looking for a robust cybersecurity program to safeguard its students and district data.

#### **Intervention Services**

The Academic Intervention Teachers and Special Education teachers provide individual instructional accommodations to students from their caseload from the school year. In the weekly individual student folders that are sent home, materials, supports, and communication notes are sent home. All materials are collected and assessed by the teachers to provide appropriate follow-up activities to the students.

Academic Intervention Teachers: Students receive additional materials that are individualized for them based on the skill deficit they exhibit. Teachers send home additional skill practice and/or instruction for the students in the form of paper packets to computer based skill reinforcement activities (e.g., ABC Mouse, Study Island, etc...) and based on their home connectivity.

**Special Education:** Teachers meet with students on a daily or weekly basis depending on their Individual Education Plan. Staff have used video conferencing, phone calls, and email to connect with students to support them in completing the schoolwork.

Consultant Teacher Services are provided by making accommodations to the instructional materials in a packet or to the video instruction that occurs with different students. Teachers connect with the students on an individual basis and provide instruction over the phone, through video conferencing, and/or video/audio downloads of the teacher providing instruction.

Resource Room Services and Related Services (Speech Language Therapy, Occupational Therapy, Physical Therapy) are provided as we can in the schedule to maintain as close as we are able to the frequency that is indicated on their Individual Education Plan (IEP). All students receive accommodations or activities to maintain the skills that were taught and when new instruction is presented. These activities are sent home on a weekly basis.

**Special Classes** students in special class placements receive instructional materials on a weekly basis and then through the use of paper packets, websites, apps, and video/audio instruction receive additional individualized instruction.

## McKinney Vento / Homeless Students

Students / Families that have been determined as Homeless are enrolled, given immediate access to instructional materials, food, and any medical resources that are necessary. If residing outside of the district, we work collaboratively with the district of residence to collaborate on the 3 areas of concern (food, medical, and instruction).

At current moment we do not have any McKinney Vento students. We work with the community agencies, district families, and neighboring school districts in discovering and identifying our McKinney Vento population. We have posted contact information on our district message board on the main strip, part of our newsletter and other communications that have gone home.

#### **Alternatively Placed Students**

We have worked with the families and organizations responsible for the students that attend an out of district placement through different programs (Residential, Private Agency, BOCES – Alternative Education, BOCES – Career Technology Education, BOCES – Special Education). All of the agencies have been providing the instructional materials and programing, in alignment with our own programming, to all of our students. Daily delivery of food and instructional technology resources (iPad and cellular hotspot, if necessary) have been provided by the district.

### English as a new Language Learner (ELL)

Students / Families receive services through our local BOCES. We work collaboratively with them to provide instructional materials, resources, and any needed technology for the instructor to work with the student.
